**REPORT:**

At Council's meeting on 7 May 1996, in relation to a Notice of Motion to remove the historic horse trough from the small park on the corner of Bells Line of Road and Terrace Road, North Richmond and place it in Heritage Park, it was resolved to defer the matter pending discussions with the North Richmond Chamber of Commerce.

At the May 15 meeting of the North Richmond Chamber of Commerce the matter was discussed and the Chamber supported the restoration of the trough and then move it to Heritage Park, suitably inscribed with a brief history.

**RECOMMENDATION:**

That the water trough be restored, including the provision of a plaque outlining its history and the trough then be moved to a suitable site in Hawkesbury Park.
